NOTICE TO TEAM MANAGERS:

- Membership with Destination ImagiNation® must be purchased prior to registering any teams. Register at www.shopDI.org.
- No team tournament registration will be accepted without payment or a purchase order and complete information about the team including **2 appraisers and 1 half-day volunteer**. Incomplete registration forms will be returned to the team manager. Registration confirmations will be e-mailed to the team manager address on the registration. PLEASE PRINT CLEARLY!!!
- Appraisers will be required to attend training on February 9, 2008. If an appraiser fails to attend the training, it could jeopardize the team's opportunity to be scored at the tournament. This is to assure a safe and appropriate tournament for the students. Please be aware that Appraisers **CAN NOT** be dismissed from their duties to view a team on tournament day. As a caution, submit the names of individuals that will understand the work and commitment the team has put into their preparation so they will be willing to give all the performers the respect and time they deserve via training and at the March 22 State Finals Tournament.
- Half-day volunteers do not have to attend training. They will be assigned to a morning or afternoon task. Some tasks involve outside work (admissions, parking) and volunteers should be prepared for any tournament administration position.
- Before any team is admitted to the Instant Challenge Experience or State Finals Tournament a letter of confirmation for the sponsoring organization must be received by CTAIC. (See pages 3 & 4 of the registration for additional information.)

Dear Team Manager/Coordinator,

Connecticut Adventures in Creativity requires that every registered team be sponsored by a youth-centered, supervising organization. This can be a school, religious organization, YMCA, Police Athletic League, library, Scouts, or any organization that is willing to accept the responsibility of youth programming and the liability associated with that task.

We do this for the protection of students, team managers, and the volunteers of Destination ImagiNation®. We hold safety as a very high priority. As such, by insuring that there is an organization on the local level that can, and is willing to, supervise the administrative tasks of a team, all teams and Team Managers will be protected from unnecessary scrutiny and liability.

We require the organizations that sponsor memberships acknowledge the responsibility and awareness of the sponsorship in the form of a letter from each organization's Director, Principal or similar leader, on organization letterhead. The ease of Internet registration may create a situation in which a school/organization could be identified as the sponsor without its knowledge. This act, is not only fraudulent, but could create a very disappointing, and possibly dangerous, situation for students and Team Managers. We are taking measures to prevent such a situation.

Attached you will find a letter to your school principal or organization director. We ask that you, or a representative of your membership, share this letter with your principal or organization director and explain the requirements. I will be happy to address any questions they may have via e-mail or at 203-623-6532. I am sure that they are as concerned about safety as you are.
